

2. The Registered office of the Trust for the time being shall be situated at No.15, AG's Office Colony, Anandnagar, Bangalore - 560 024. The Board of Trustees may shift the registered office to any other place/s from time to time as and when they decide to do so.
3. (a) The Author of the Trust herein hereby declares the sum of Rs. 10000/- (Rupees Ten Thousand only) as the Trust Property and assigns, transfers and delivers the same to the Members of the Board of Trustees herein who shall hereafter stand possessed of the Trust Property and funds (which expression wherever the context permits shall hereafter include all investments in cash or in kind or in any other nature whatsoever in to and for which the said Property or any part/s thereof may from time to time be converted, varied or exchanged and/or such other investments as may be held by the Board of Trustees from time to time in relation to these presents with all income, property, additions and alterations thereof by using and/or investing such Trust Property) upon trust for the objects set-out herein with and subject to the provisions and conditions hereinafter contained in these presents.

(b) The Board of Trustees shall hold the Trust Property upon trust for carrying out the objects of the Trust and all the benefits, income of all kinds and description arising, accruing or received from the Trust, properties shall be used for such purposes and in accordance with the directions contained in these presents.



- iv) To assist in the promotion of research and development in various fields and/or for undertaking, prosecuting and encouraging higher education and research work in any branch of engineering, technology, electro-therapy, radiology, bacteriology, medical sciences, horticulture, agriculture or any other branch or branches of modern applied science in its widest and most comprehensive sense.
- v) To assist students in pursuing their academic professional and other studies by providing scholarships, hostel facilities, supply of good books and other requirements free of cost or at concession rates or otherwise and generally to render assistance without any profit motive.



vi) To promote music, drama, dance and other fine arts and/or to establish institutions for propagation and implementation, training in these fields and to render assistance to students in the foregoing fields.

vii) To establish, maintain and support libraries, museums, reading rooms, auditorium for advancement of education, cultural activities and knowledge in general.

viii) To spread education, knowledge and learning in all its branches by way of publication of books, magazines, conducting lectures, seminars and in any other manner not involving making of profit.

ix) To set up hospitals or other medical institutions and running them or granting subscriptions and donations to hospitals, charitable dispensaries, convalescent homes, asylums, and other public institutions for administering medical relief to the poor.

x) To grant, endowments, help or support to hospitals, maternity homes, sanatoriums and dispensaries and old age homes.

xi) To grant medical help to the poor and deserving persons at all times including during epidemic, famine, floods, earthquake or any unforeseen calamity or war like operations.

xii) To establish, support, maintain or help by monetary gifts or otherwise, centers for research in medical sciences, including ayurvedic, homeopathic and for that purpose to provide necessary amounts to deserving persons in carrying out research.

xiii) To distribute free food, clothing and the like to the poor and needy free of cost or at concessional rates and/or to maintain, run and assist in the distribution food, poor feeding and the like and to distribute food, clothing and the like.

xiv) To help poor widows, aged persons, physically and/or mentally retarded persons including setting up of homes, orphanages, home for the aged, poor homes and the like.

xv) To aid, assist, donate, subscribe or otherwise contribute funds to societies, institutions, trusts and other funds for promotion of any of the foregoing objects or whose objects are similar to those of this Trust and which enjoy recognition under section 80G of the Income Tax Act, 1961 as amended from time to time.

xvi) To donate, contribute funds to such institutions which are recognized under section 80G of the Income-tax Act, 1961 as amended from time to time and/or and for such temples and places of archaeological or artistic importance as are notified under section 80G (2) (b) of the Income-tax Act, 1961 as amended from time to time.

xvii) To aid, assist and/or set up institutions for imparting academic, professional and vocational training to children and women and/or for rehabilitation and care of women and children and to provide them food, shelter, clothing and other necessities of life.

xviii) To carry out all such acts, deeds and things, which are incidental to or necessary for the promotion of the aforementioned objects, without, reference to caste, creed or religion.

5. BOARD OF TRUSTEES

(a) The Author of the Trust hereby appoints, constitutes and nominates the Board of Trustees (consisting of herself and the other trustee herein as the First Members of the Board of Trustees) as the First Trustees.

(b) The total strength of the Board of Trustees shall not be more than nine and shall not be less than two.

(c) The members of the Board of Trustees with two thirds majority shall have the power to add one or more persons as Members of the Board of Trustees for such period as they may deem fit and fill-up any vacancy in the Board within the aforementioned limits as they may deem fit from time to time. Any person/s appointed as Member by the Board of Trustees shall hold such office only for such period for which he is appointed or till he voluntarily resigns whichever is earlier.

(d) A Single member may constitute the Board when the number of Members are reduced to one and such Member shall constitute Board only for a period of three months from the date of such reduction of strength of the Board to one and such member shall appoint one or more members to increase the strength of the Board to the minimum of two.

(e) In the event not even a single member of the Board of Trustees exists or is appointed, the power of appointing trustee/s and the Member of Board of Trustees shall vest with the Court having jurisdiction over the place where the registered office of the Trust is situated.

(f) A member of the Board of Trustees may be removed, provided at least two third majority of the Members of the Board of Trustees as constituted from time to time give their consent to the removal of such member.

(g) The Board of Trustees shall be responsible for maintenance of accounts and for the various activities of the Trust and shall conduct the activities of the Trust in accordance with the stipulations set-out herein and for fulfilling the objects of the Trust. The Board of Trustees may delegate all or any of the powers vested in them to such person/s and for such purpose as they may deem fit and may revoke, vary, alter, rescind such powers so delegated.

(h) The Board of Trustees may from time to time appoint one or more of their body as Managing Trustee of the trust for such period as the Board may deem fit and may fix the terms and conditions of appointment and the duties and

responsibilities of the Managing Trustee of the Trust. The Board shall have the power to remove the Managing Trustee even before the expiry of the office.

(i) The powers vested in the Board shall be exercised by a resolution passed at a meeting of the Board or circulated among the Members of the Board and accepted by a majority of members. In case of a tie, the Managing Trustee shall have an additional vote called casting vote.

(j) Any member of the Board of Trustees may convene the meeting of the Board of Trustees by serving at least seven days clear notice of the meeting on the other members of the Board of Trustees in writing and setting out there in the matters to be discussed, the place of the meeting, the day, date and time of the meeting. The Board of Trustees shall meet from time to time as and when necessary to transact the business of the Trust and for considering the betterment of the Trust and its assets. There shall be at least four meetings in a calendar year of the Trust. The quorum for the meeting of the Board of Trustees shall be two. The Board shall cause the proceedings of its meetings recorded in a book.

(k) Any Member of the Board may resign; such membership and such member shall cease to be a member upon the acceptance of his resignation.

(l) Any Trustee shall automatically cease to be a Trustee in the following cases.

The Trustee

- Becomes bankrupt or lunatic
- Absents himself / herself without leave of absence from 3 consecutive meetings of the Board of Trustees.
- Enters into a contract or arrangement directly or indirectly with the Trust without first disclosing his / her interest in such contract or arrangement at a meeting of the Board of Trustees.
- Is found guilty by a Court of Law of an offence involving moral turpitude.

6. POWERS OF THE BOARD OF TRUSTEES

With a view to carry out the objects of the Trust hereinabove mentioned and to augment its funds and to administer them and in discharge of their duties, and without prejudice to the generality of any powers hereby or by law conferred or implied or vested in him/them as Trustee/s, the Board of Trustees shall have the following powers:-

- To apply and use the funds of the Trust for all or any of the objects of the Trust and to accumulate the surplus and unapplied portion of the said income under 'Surplus Account' and invest the same, subject however to complying with requirements of the Income-tax Act, 1961, as amended from time to time relating to accumulation of income and investment thereof.
- To receive any money or other assets in any shape or form as and when given by the Author of the Trust or any other person/s as gift or donation and to hold the same as part of the capital fund of the Trust if such donor expresses his desire to so treat the same, or to make it available for the application to further the objects of the Trust treating the same as income of the trust.
- To reimburse themselves or pay and discharge out of the funds or any Property of the Trust, all expenses that may be incurred in or about the execution of the Trust and powers of these presents including reasonable amount of traveling expenditure incurred in the course of discharge of their duties including attending to any meeting of the Board of Trustees.
- To compromise, compound, abandon, submit to arbitration or otherwise settle any actions, suits, proceedings, debts, claims or things whatsoever arising out of the administration of the Trust fund or any institutions maintained and for any of these purposes to enter into, give, execute and do such agreements, instruments or composition or arrangements, releases and other things as

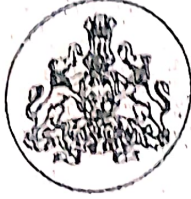

- vi. To receive, collect or realize or cause collection or realization of all income that accrue or become due on all or nay investments.
- vii. To represent the Trust in all Courts (original and Appellate) or before any authorities and departments of Government, Semi-Government or local authority.
- viii. To execute or negotiate papers and documents (whether negotiable or non-negotiable), to receive monies or other assets and to grant receipts and discharges.
- ix. To sign and verify all pleadings, memoranda of appeal, petitions and applications of all kinds, to compromise, abandon or refer to arbitration the whole or any part of the claim by or against the Trust, to engage lawyers and to take all such other necessary steps.

- xiv. To do all other acts, deeds, matters and things which may be deemed necessary for carrying out the objects of this Trust or its administration.
- xv. To appoint committees, sub-committees from outsiders and/or among the Members of the Board and to assign duties and seek suggestions for the purpose of working of the Trust and to frame such rules and regulations for the management and administration of the Trust and institutions as the Board of Trustees may think fit and to alter or vary the same from time to time and to make new rules and regulations which shall not be inconsistent with the terms of these presents.
